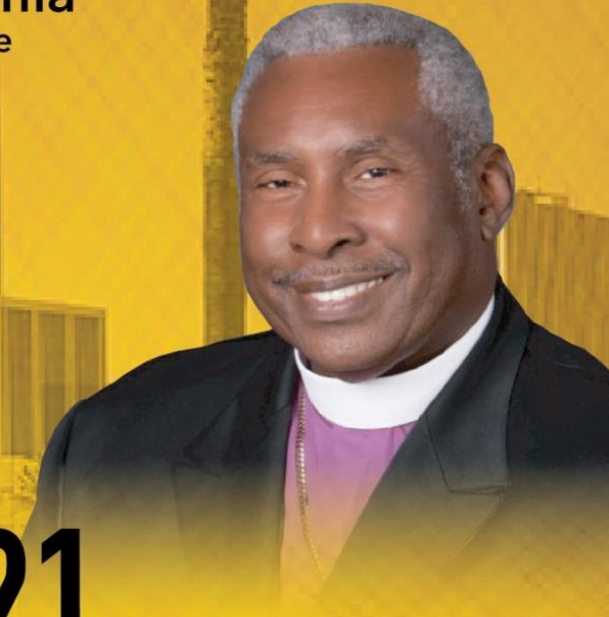

Convocation in Memphis, Tennessee. Shortly thereafter he officially released his position as Prelate of First Ecclesiastical Jurisdiction. He was succeeded by Regional Superintendent Joe L. Ealy, an Administrative Assistant to Bishop Blake and Pastor of the Gospel Memorial Church of God in Christ, Long Beach, California.

Bishop Ealy has served as the pastor of Gospel Memorial Church of God in Christ for more than 55 years. He is known in the community as a leader “with a heart for the people.” The church has a positive impact on the community and is recognized as a beacon light of hope in the City of Long Beach. He has received numerous awards and commendations from Cities, Counties and other entities for his commitment to serving the community through ministry in the Long Beach/Los Angeles area. Bishop Ealy began preaching at the age of nine in Riverside, California and he recently celebrated 72 years in the ministry. Bishop Ealy has served the First Ecclesiastical Jurisdiction of Southern California in numerous leadership capacities, including District Superintendent, Regional Superintendent and the Southern California First Jurisdiction Referral Committee.

On November 9, 2009, at the Holy Convocation in Memphis, Tennessee, Bishop Ealy, in a historic Ceremony, was consecrated as the Jurisdictional Prelate of First Ecclesiastical Jurisdiction of Southern California. The banquet honoring Bishop Joe L. Ealy was an occasion to remember. One of the highlights was the tribute to his late wife, First Lady Betty Louise Ealy. She was a woman of beauty and strength; the epitome of grace and love. Evangelist Betty Ealy was a shining example of stewardship, service, a beautiful wife, and mother. She devoted her life to support the ministry of her husband and the church.

Bishop Ealy is characterized as having an inclusive ministry. He has the spirit of Bishop Charles Mason in that he reaches out to everyone, making all feel a part. He extends himself in order to help all pastors and elders enhance their ministry. One of his notable achievements has been the implementation of the pastor’s MetLife insurance program. The jurisdiction remains strong under his leadership; new churches have been added and the legacy of excellence set by his predecessors continues.

recommendations on all Jurisdictional financial affairs. At the yearly annual business meeting the required Financial Reports were presented and adopted. Bishop Blake also organized and sponsored numerous church growth seminars. Under his tenure many renowned speakers and musical guest were invited to participate in the annual Holy Convocation.

He established the first Transition House and Elder Art Glass deeded the Bonnie Brae House to First Jurisdiction. Bishop Blake spearheaded the renovation of the Bonnie Brae House. Knowing the significance of the house, he wanted it to be a place for peaceful meditation.

In April 1991, under Bishop Blake's dynamic leadership, First Jurisdiction contributed the largest single contribution to the national church from any Jurisdiction in the history of the Church of God in Christ. Bishop Blake has received numerous awards and commendations. In 1988 the Crouch Temple was sold. The proceeds were used to establish an "Expansion Fund." Some of the proceeds were used for loans to the local churches to assist pastors in making necessary repairs or pay off loans. Bishop Blake has a heart for God's people and he has these encouraging words for the saints "I see you in the future and you look much better than you look right now."

Mother Barbara McCoo Lewis was selected as Jurisdictional Supervisor of Women by Bishop Charles E. Blake on May 5, 1988. Mother Lewis received her official appointment from the General Supervisor of Women, Dr. Mattie McGlothen at the Holy Convocation in Memphis, Tennessee on November 11, 1988. Under her leadership, great growth occurred.

Mother Lewis initiated the State Women's Department slogan "We Progress with Team Effort." Mother Lewis was the visionary for Hale Morris Lewis Manor, the 4.7 million dollar forty-one (41) unit residential Senior Citizens Complex erected and opened in 2002 in the heart of Los Angeles. Designed for the resident's enjoyment is the "Thelma A. Johnson Community Room," the "Dr. Barbara McCoo Lewis Chapel," and the beautifully landscaped memorial bricked "Lady Mae Lawrence Blake Courtyard."

In November 2007, Bishop Charles E. Blake was consecrated Presiding Bishop of the Churches of God in Christ at the Holy

JURISDICTIONAL BRIEF HISTORICAL SKETCH

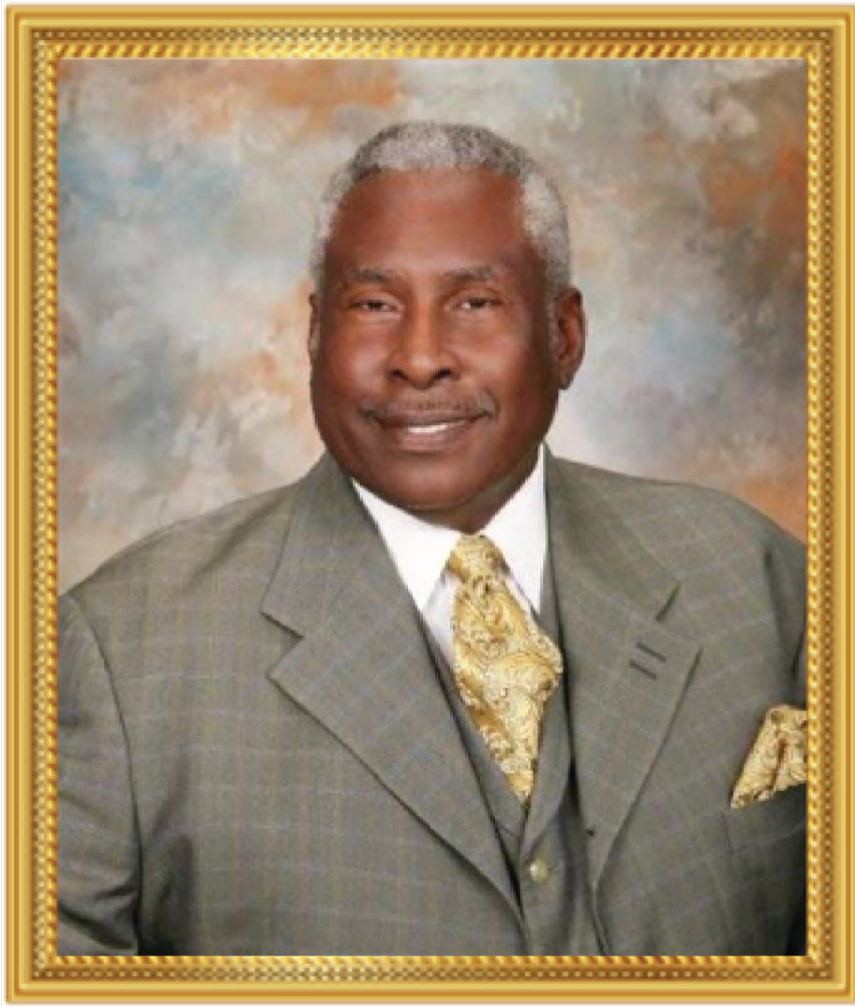
In the year of 1914, the Church of God in Christ was established in California. Overseer E. R. Driver was appointed the First Overseer by Bishop Charles Mason, founder of the Church of God in Christ. He evangelized and traveled extensively encouraging churches to grow and to witness to sinners. Under his administration, many churches were established. His wife, Mother Annie Driver, served as State Supervisor of Women. Overseer Driver served from 1914 – 1924. His work will never be forgotten.

In 1924, Overseer E. M. Wilson was appointed as State Overseer. Under his leadership, new churches were established. Mother Celia Thomas served as State Supervisor at this time. Not only were new congregations started, but the existing ones experienced significant growth. Bishop Wilson served from 1924 – 1928.

During the winter of 1931, Bishop Samuel Martin Crouch was appointed as State Bishop of California. Bishop Crouch was a builder of men and churches. Mother Leanna Osborne Hale worked beside Bishop Crouch as State Supervisor. Under this administration, Southern California became the largest jurisdiction in the Diocese. Bishop Crouch died August 14, 1976. In 1976, Bishop Junious Augustus Blake, Sr. was appointed and Mother L. O. Hale remained Supervisor.

Bishop J. A. Blake was also a builder of men. He was a man of God-given wisdom, unique skill, charisma, skilled in the Word and administration. Most of all, he loved God's people. After the demise of Mother L. O. Hale in 1981, Bishop J. A. Blake chose Dr. Lillian Ann Morris as State Supervisor. At the demise of Bishop J. A. Blake, the General Board, led by Presiding Bishop J. O. Patterson, Bishop Charles E. Blake was appointed in June 1985.

Bishop Blake's visionary insight progressively moved the First Jurisdiction to new dimensions. The Jurisdiction experienced tremendous growth and unity. He was the first to have the Annual Workers' Meeting travel to various Regions in the Jurisdiction, enabling total involvement throughout the Jurisdiction. Bishop Blake is growth orientated. He established the first organizational Board of Directors for the Jurisdiction. The group consists of highly qualified business and financial professionals. This group makes

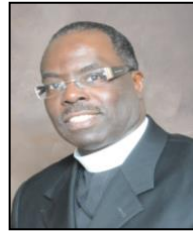

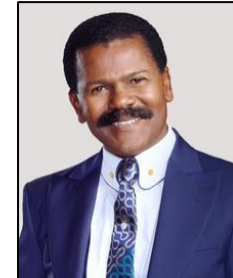
